### **General Information and Instructions:-**

- i. Interested candidates having the requisite qualification and experience may appear for registration on date as mentioned against each post. Registration timing is from 11.00 AM to 12.30 PM. No application will be received after scheduled timing of registration. After registration candidates will be shortlisted on the basis of required eligibility criteria and shortlisted candidates may be asked to stay back for interview. Candidates not fulfilling the requirement will not be interviewed.
- ii. **For employees under OSH&FWS** : The EC Committee has recommended for relaxation in age and weightage in marks obtained in recruitment examination to be given to the employees of the OSH&FW Society as follows:
  - a. To avail the benefit of age relaxation and weightage, the employees concerned should have completed a least three terms of contractual services (11 months each) under the OSH&FW Society.
  - b. The remarks in PAR of the employee concerned must be Outstanding or Very Good for the preceding three (3) terms of contractual service.
  - c. The age relaxation for the employees for the applied post may be allowed @ 1 year for each contractual term of services upto a maximum of 10 years, over and above the maximum age limit prescribed in the Advertisement for the said post, subject to an age ceiling of 55 years.
  - d. Employees who have cleared all the steps in the recruitment process upto the final level of selection shall be eligible for award of grace marks to the extent of 01 percentage mark for each completed term of services upto a maximum of 10 percentage marks of the total marks which will be added to the total score secured by the said employee.
- iii. Candidates are required to come for interview with duly filled in application in prescribed format, available in the official website : [www.koraput.nic.in](http://www.koraput.nic.in) and bring all certificates / testimonials, in original and a set of self attested photocopies of the same, in support of age, qualification and experience, for verification. Candidates are also required to bring two recent passport size colour photographs and self photo ID proof (Voter ID card / PAN card / Driving License / Aadhar Card / Passport). Incomplete application in any form will be rejected.
- iv. **Knowledge in Odia:** The candidate must-
  - a) be able to read, write and speak Odia;
  - b) have passed middle school examination with Odia as language subject; or
  - c) have passed Matriculation or equivalent examination with Odia as medium of examination in non-language subject; or
  - d) have passed in Odia as language subject in the final examination of class VII from a school or educational institution recognized by the Government of Odisha or the Central Government; or
  - e) have passed a test in Odia in Middle English School standard conducted by the School and Mass Education Department.
  - f) Must be above 21 years
- v. In case the marks obtained are in the form of CGPA, OGPA, DGPA, GPA, CPI etc., a certificate for conversion as applicable to percentage of marks shall be submitted at the time of submission of application form. Certificate towards AICTE recognition of institutions shall also be submitted at the time of submission of application form, wherever applicable, without which the application shall not be considered & shall be rejected.
- vi. **For the post AYUSH Doctors** : Age Relaxation for Women, SC, ST & SEBC category and Physically Disable, Ex-Sports Person, Ex-Serviceman category will be applicable as per Govt. norm. A candidate can avail only one relaxation that most beneficial to him/her.
- vii. Over aged, under qualification and short of requisite percentage of marks in the prescribed educational qualification shall be rejected. Candidates will be selected on the basis of selection process as applicable. Only shortlisted candidates will be called for participation in the selection process.
