The applications should reach to the Project Director, DRDA, Koraput on or before 11.12.2021 by 5.30 PM sharp by Registered Post/Speed Post only. Applications received after last date or on any other mode shall be liable for rejection.

**ELIGIBILITY:-**

- Age:** The applicant shall not be below 18 years and shall not exceed 40 years as on the 1<sup>st</sup> day of the month during which the recruitment process viz. calling for application starts i.e. 01.11.2021.
- Educational Qualification:**
  - The minimum qualification of the candidate is 10+2 pass or its equivalent qualification as notified from time to time by CHSE Odisha with computer proficiency of 'O' Level and use of Odia language in Computer. Computer proficiency is only qualifying in nature and shall not count for determining the order of merit.
  - Equivalent Qualification of 10+2 for the purpose of equivalency of Higher Secondary (+2) Examination conducted by the institutions declared equivalent by the CHSE, Odisha shall be considered.
  - The candidates having qualification(s) of computer proficiency like PGDCA, BCA, MCA, M.Sc. (Computer Science) from any Government recognized Organizational Universities being higher than the 'O' Level will be considered provided such candidate fulfil all other eligibility criteria prescribed in the extant guidelines.

- d) The candidates submitting Computer Proficiency certificates from organizations other than Government recognized Institute/ University shall not be considered.
- e) The candidature of such PGDCA qualified candidates applying for the post of GRS, whose PGDCA certificate is obtained before completion of graduation should not be considered.

4. **Criteria for Selection of GRS:** The Selection of candidates shall be strictly on the basis of marks obtained in 10+2. Marks secured in fourth optional **shall not be included.**

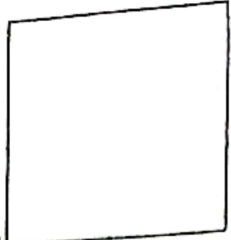

Sub:-Clarification regarding reservation for Persons with Disabilities(PwDs) in the post of GRS.

Sir,

I am directed to say that some Districts have solicited clarifications as to whether there will be reservation for Persons with Disabilities(PwDs) while filling up the posts of Gram Rozgar Sevaks. Considered views of the SS&EPD Department, Government of Odisha were sought for in this connection.

As per the views of SS&EPD Department, pursuant to section 34 (1) & 34 (2) of the Rights of Persons with Disabilities Act, 2016 read with Para- 18 of the Social Security & Empowerment of Persons with Disability Department Resolution No.7140 dated 5th September, 2017, there will be reservation in the post of GRS for PwDs with following two categories of benchmark disabilities under clauses (b) & (c) of Section 34 (1) of the Rights of Persons with Disabilities Act, 2016 namely-

- (b) deaf and hard of hearing;
- (c) locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid attack victims and muscular dystrophy.

Reservation will be 4% of the total number of vacancies proposed to be filled up. Out of which, two percent each shall be reserved for the persons with the above two benchmark disabilities.

I would, therefore, request you to follow the above principles scrupulously in order to provide reservation for PwDs while filling up of the vacant posts of GRS.

This has been approved by the Government in SS & EPD Department vide their Noting 28 to 33 in this Department File No.PT3-PR-NREG-ESTT-0017-2019 and Principal Secretary, PR & DW Department.
