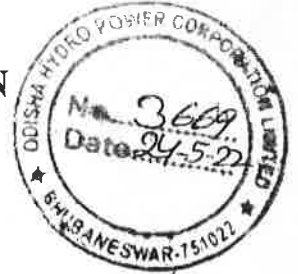

Odisha Electricity Regulatory Commission (OERC), a statutory body constituted by Government of Odisha as per Odisha Electricity Reform Act 1995, invites applications for filling up post on direct recruitment/deputation basis from the officials of Central/State Governments, Public Sector Undertakings, Power Utilities, Regulatory Commissions, Universities (both Public and Private), Autonomous Bodies under Government etc. The details of posts like scales of pay, minimum / essential qualifications and additional desirable qualifications and experience etc. are given in Annexure-I.
2. The age of the applicant should not be more than 57 years as on 1st June 2022. However, the age limit of the candidate may be relaxed in case of serving candidates working with Central Government/State Government/ Central PSU/ State PSU/ Regulatory Commissions/ Public Universities both at State and at Central level with relevant experience.
