(1) Paradip Port Authority intends to engage 05 (five) nos. of General Duty Medical Officer on **contractual basis**. The details regarding posts showing qualifications, remunerations etc. for the post are as below:

#### B) Terms & Conditions:

- i) PPA reserves the right either to cancel the circular or increase/decrease the number of engagements without assigning any reason thereof.
- ii) The engagement will be for **02 years** and extendable further based on the performance and requirement of Paradip Port Authority.
- iii) The selected candidate will be paid a monthly consolidated remuneration of Rs.75,000/- per month with an enhancement of remuneration @3% per year.
- iv) The selected candidate will be provided with PPA residential quarters on usual rent, subject to availability and energy & water charges as applicable to Port employees,
- v) The selected candidate will be posted under the control of the office of Chief Medical Officer, Paradip Port Authority.
- vi) The selected candidate will directly report to the Chief Medical Officer, PPA, or any other officer nominated by him, for his daily performance.
- vii) The selected candidates will be required to perform duties of General Duty Medical Officer (on contract) during different shift as may be assigned by the Chief Medical Officer, PPA.
- viii)The selected candidates will not be allowed to avail any kind of leave except National Holidays and 12 days Casual Leave with prior permission of Chief Medical Officer, PPA.
- ix) The selected candidates will be allowed to avail weekly off days as would be decided by the Chief Medical Officer, PPA.
- x) The selected candidate should not leave headquarters without prior permission of Chief Medical Officer, PPA.

- xi) The selected candidates will be entitled medical consultation on treatment on free of cost in Paradip Port Authority Hospital for self only. However, no reimbursement for medicine/ medical articles purchased from outside, diagnostic test done outside or treatment received outside will be allowed. This restriction will not apply for treatment of any injury sustained due to accident, occurred in the course of and arising out of the contractual engagement.
- xii) The selected candidate shall be responsible for charge and care of the PPA money, goods and stores and all other property that may be entrusted on him/her and he/she will be accountable for the same.
- xiii)The selected candidate will maintain absolute integrity and devotion to duty and will be liable for penal action for misconduct or causing loss to Port property attributable to her/him during the period of contract engagement.
- xiv) The contractual engagement may be terminated at any time without assigning any reason thereof by giving one month notice or either side and in special case immediately. In the event of failure to give notice by the employee, one month salary or part, in lieu thereof, will be recovered.
- xv) The engagement is purely on contractual basis and the engagement on contract basis will not confer any right for claiming regular appointment etc.
- xvi) Canvassing in any form will lead to disqualification.
- xvii) No TA/DA is admissible for appearing in interview.
- D) Selection Methodology: The selection will be based on Interview.
