Duties and Responsibilities of Guest Faculty:

Teachers appointed as Guest Faculty will discharged the following duties:

a) Teaching of concerned subject as per CBSE standard.

b) Timely correction of class and home assignments, testpapers, projects etc.

c) Setting of Question papers for various tests and exams.

- d) Preparation of lesson plans and maintaining academic record of students.
- e)Preparing students for curricular/co-curricular activities, house activities, various cultural competitions etc.

f) If required, escorting the students for activities outside the school.

g) Performing invigilation duty/evaluation work as and when assigned.

h) Any other work assigned by the Principal.

Terms and Conditions:

- I) Guest Faculty engaged, would have no claim or right for appointment on a regular basis nor will they be a part of the cadre of teachers of Eklavya Model Residential School (EMRS).
- II) There shall not be any upper limit in taking number of classes.
- III) Guest Faculty will not be entitled for pay, If remains absent on working day. In case of absence from duty, payment will be calculated on pro rata basis.

IV) Working hours shall be same as other teachers.

- V) The engagement of these Guest Faculty teachers will automatically come to an end once a regular/contractual teacher is appointed/engaged against the vacant post in EMRS.
- VI) The Guest Faculty so engaged shall also be entrusted with correction and evaluation work of the concerned subject in the EMRS and he/she will not be entitled for extra honorarium for such work.
- VII) The performance of the teacher will be reviewed on regular basis. If any teacher is found to be non- performing or engaged in activities amounting to misconduct he/she shall be disengaged by the EMRS Principal under intimation to District Welfare Officer/Secretary (OMTES).
- VIII) Maximum age for Guest Faculty at the time of application shall be Sixth Two(62) & the retired teacher engaged as Guest Faculty under the scheme shall be disengaged on attaining the age of sixty five(65).

IX) Unauthorized absence for a continuous period of 15 days or more will automatically terminate his/her engagement.

Eligibility criteria:

a) TGT:Graduate with 50% marks in concerned subject/combination of subjects and in aggregate with B.Ed.

b) Proficiency in HINDI & English.

c) Computer Knowledge

Honorarium:

The Guest Faculty will be paid consolidated honorarium as mentioned below: 1.TGT-Rs.22000/-p.m

Document Required:-

1. Self-attested xerox copies of all the certificates and mark sheets application from HSC onwards along with the filled in form(Annexure-01).

2. One recent Color passport size photographs of the candidate

pasted on the application form.

3. All the original Certificates and marksheets from HSC onwards must be kept with the candidates for verification.

4. If any candidate has experience in his concerned field, the certificate in original must be produced before the committee.

5. One identity and address proof of the candidate will be required.

Important Instruction:

1. Registration of the candidates will be started at 8.00 AM on 11.10.2022 in the Office of the Principal, EMRS, KIRMIRA, Jharsuguda. So interested candidates are requested to reach the venue on/before 8.00AM on the above said day without fail.

2. Interview will be held at 9.30 AM onwards.

3. Preference shall be given to the lady candidates and candidates satisfies the eligibility criteria with experience in the same field(especially from KV/JNV).

4. The entire selection procedure will be decided by the Selection

Committee which can't be challenged.
