### ELIGIBILITY/ TERMS AND CONDITIONS FOR THE POST OF PGTs

- 1. The post of PGTs can be filled up on part time contractual basis.
- 2. Contractual appointments are made till the end of the session or till the regular teacher will join, whichever is earlier.
- 3. Teachers engaged on contractual basis, would have no claim or right for appointment on a regular basis nor will they be a part of the cadre of teachers of OAVS.
- 4. The payment will be on pro-rata basis as decided by OAVS.

#### The following must be ensured

- 1. The teacher should posses the required educational qualifications prescribed For direct recruitment to the post.
- 2. Minium and Maximum age limit shall be 18 and 65 years respectively.
- 3. He/She must be engaged till such time the regular teacher joins or the end of Of academic session, whichever is earlier.
- 4. Candidature of a contractual teacher who have served in an OAVin a year may Be considered in subsequent year(s) by selection committee for a fresh Appointment as contractual teachers, by following due procedure.
- 5. The teacher engaged should be addressed by the Principal in OAVs.

## Duties and responsibilities of Contractual teachers:

- a) Regular classroom activity/copy checking.
- b) Invigilation duty/Evaluation work.
- c) Helping students and colleagues in preparation and organization of different curricular / Co-curricular activities in the Vidyalaya.
- d) Any other works assigned by the Principal.
