**Empanelment to the post of Mediator in the District Consumer
Disputes Redressal Commission, Deogarh, Odisha**

Application are invited from eligible persons having following criteria for Empanelment as " Mediator" for a period of 5 years in respect of issues involved in a Consumer Dispute pending before the District Consumer Disputes Redressal Commission, Deogarh. The empanelment shall be conducted in accordance with the provision of Consumer Protection Act, 2019 and as specified in the Consumer Protection (Mediation) Regulations, 2020.

Eligibility for empanelment as Mediator:-

The following persons shall be eligible to be empanelled in a Mediation Cell-

- i) Retired Judge of Supreme Court of India;
- ii) Retired Judge of High Courts;
- iii) Retired Members of Consumer Commission;
- iv) Retired District and Session Judges, retired Additional District and Session Judges or other retired Members of the Higher Judicial Services of a State;
- v) Retired Judicial Officers, having experience of not less than ten years;
- vi) An advocate with a minimum experience of ten years at Bar;
- vii) The Mediator empanelled with the Mediation Cell of the Supreme Court of India, High Court or a District Court;
- viii) A person having experience of at least five years in mediation or conciliation;
- ix) Expert or other professionals with at least fifteen years' experience or retired senior bureaucrats or retired executives.

AGE : The above person should be above 30(thirty) years of age.

Fee of Mediators:-

A consolidated fee shall be paid to the empanelled mediator, who conducts the mediation proceedings and such fee as may be fixed by the President of this Commission as per the provisions of Consumer Protection Act, 2019 and as specified in the Consumer Protection(Mediation) Regulations, 2020.


Disqualifications for empanelment:- (1) The following persons shall be disqualified for being empanelled as Mediator:-

- i) A person who has been adjudged as insolvent;
- ii) Person against whom criminal charges involving moral turpitude are framed by a criminal court and are pending;
- iii) A person who has been convicted by a criminal court for any offence involving moral turpitude,
- iv) A person against whom disciplinary proceedings have been initiated by the appropriate disciplinary authority and are pending or have resulted in a punishment.

(2) A person who is or has been interested in or connected with the subject matter of the consumer dispute or is related to or has been associated or connected in any manner, including in a professional capacity with any of the parties to the consumer disputes or any of their associates, affiliates, promoters, holding companies, subsidiaries companies, partners, directors or employees shall be disqualified for being nominated as a mediator in that case.

(3) Selection procedure:-

The Selection Committee shall determine its procedure for making its recommendation, after taking into account number of applications and suitability, integrity as well as relevant experience of the candidates.


