# ADVERTISEMENT FOR RECRUITMENT TO THE POST OF DIRECTOR CURRICULUM DEVELOPMENT (Tenure Based): (UR-01)

Applications in prescribed format along with details of qualification, experience and contribution to profession/research are invited from Indian Nationals for recruitment to the post of **Director**, **Curriculum Development**, **BPUT**, **Rourkela**. The appointment will be tenure based for a period of 05 years. The application format and other details can be downloaded from the BPUT website (www.bput.ac.in).

Pay Scale: Entry pay of Rs. 1,44,200 + DA at Pay Level-14 as per the Odisha Revised Scale of Pay (for Teachers of Engineering College/ Degree level Technical Institutions / Universities) Rules, 2019 as applicable to the Professors of BPUT, Odisha (relevant to pre-revised scale of Rs. 37,400-67,000 + AGP Rs.10,000 of Govt. of Odisha for the University). If a Teacher from a Govt./Semi Govt. Institution is deployed in the same post, then his/her pay may be protected as per BPUT rules.

### Essential Qualification and Eligibility criteria requirements (within last date of Application):

a) Must have Ph.D. degree in Engineering / Computer Application / Management / Sciences / Architecture/ Pharmacy.

and

b) Must have First Class or equivalent either at Bachelor's or Master's level in the relevant branch and 60% marks or 6.75 CGPA in aggregate shall be considered equivalent to first class if first class or division is not awarded by the concerned institution or the equivalence CGPA as notified by the concerned institution. A copy of the notification must be attached for proof.

and

c) Must have minimum 10 years of experience in Teaching/Research/Industry in UGC/AICTE approved institution/organization/ industries.

and

d) Out of 10 years of above experience minimum 03 years of experience should be as Associate Professor or equivalent post.

and

e) Must have at least 06(six) numbers of research publications at the level of Associate Professor in SCI/UGC/Scopus/AICTE approved listed Journals and must have successfully produced at least 02 Ph.D. as Supervisor/Co-Supervisor as on the last date of the application

OR

Must have 10(ten) research publications at the level of Associate Professor in SCI/UGC/Scopus/AICTE approved list of Journals as on the last date of application.

f) Should be within 55 years of age on the last date of application i.e. 03/03/2023.

#### **Application Fees:**

A candidate is required to pay a non-refundable fee of Rs.1000/- (Rs.500/- for ST/SC category) through SB Collect.

Last date for Receipt of Application:

The applications will be accepted only by Speed Post; No Hand Delivery or any other mode is acceptable. In-service candidate(s) need to forward his/ her application through the employer or need to submit a 'No Objection Certificate' from the employer at the time of interview. The sealed envelope containing the application form and other documents should be super-scribed as "Application for the post of "Director Curriculum Development, BPUT, Rourkela- 2023" and reach to the Registrar, BPUT, Chhend, Rourkela- 769015 on or before 03/03/2023. Minimum eligibility does not ensure that a candidate will be called for interview and/or selected; the decision of the authorities is final. No correspondence in this regard shall be entertained.

#### **General Information & Conditions:**

- Mere fulfillment of qualifications, eligibility and experience requirements etc. does not entitle a candidate to be called for an interview.
- The University reserves the right to fill-up or not to fill-up the post advertised or even to cancel the entire selection process without assigning any reason thereof.
- 3. No correspondence whatsoever will be entertained from the candidates regarding postal delays, conduct and result of interview and reasons for not being called for interview or selection.
- 4. Persons employed in Government, Semi-Government, Private or Autonomous organizations need to apply through proper channel or they shall be required to submit the No Objection Certificate from the Employer at the time of interview.
