

**Empanelment to the post of Mediator in the District Consumer Disputes  
Redressal Commission, Sundargarh-II, Rourkela, Odisha.**

Application are invited from eligible persons having following criteria for Empanelment as Mediator for a period of 5 (Five) Years in respect of issue involved in a Consumer Dispute pending before the District C.D.R.Commission , Sundargarh-II, Rourkela. The empanelment shall be conducted in accordance with the provisions of the Consumer Protection Act,2019 and as specified in the Consumer Protection (Mediation) Regulations,2020.

1. Retired Judges of a Supreme Court of India
2. Retired Judges of High Courts.
3. Retired Presidents of District Commission
4. Retired Members of District Commission
5. Retired District and Session Judges, Retired Additional district and Sessions Judges or other retired Members of the Higher Judicial Services of a State.
6. Retired Judicial officers having experience of not less than ten years.
7. An Advocate with a minimum experience of ten years at BAR.
8. The Mediator empanelled with the Mediation Cell of the Supreme Court of India, High Court or a District Court.
9. A person having experience of at least five years in Mediation or Conciliation
10. Expert or other professionals with at least fifteen years experience or retired senior bureaucrats or retired executives.

**AGE :** The above persons should be above 30 ( THIRTY) Years of age.

**Fees of Mediators:**


A consolidated fee shall be paid to the empanelled mediator who conducts the mediation proceedings and such fees as may be fixed by the President of Dist.Commission as per Consumer Protection Act,2019 and as specified in the Consumer protection (Mediation) Regulations,2020.

**Disqualification for Empawnelment:**

1. A person who has been adjudged as in solvent



2. Person against whom Criminal Charges involving moral turpitude are framed by a Criminal Court and are pending.
3. A person who has been convicted by a Criminal Court for any offence involving moral turpitude.
4. A person against whom disciplinary proceeding have been initiated by the appropriate disciplinary authority and are pending or have resulted in a punishment.
5. A person who has been interested or connected with the subject matter of the Consumer Disputes or is related/associated in any manner, including in a professional capacity with any of the parties to the Consumer Disputes or any of their associates shall be disqualified for being nominated as mediator.
