1. The contractual engagement shall be made for a period of one year from the date of his/her joining.
2. The appointee has to discharge such duties and in such a manner, as may be prescribed by District Audit Officer,LFA,Boudh from time to time.

The retired officer against whom a vigilance Case or Departmental proceeding or criminal prosecution is contemplated or pending or who has been penalised for misconduct during the period up to five year preceding his/her retirement or is a member of a political party will not be considered eligible for re-engagement.
4. The selection will be governed by the procedure and rule laid down in GA Department Resolution No.23750/GAD,Dtd.27.08.2014.
5. Consolidated remuneration of the contractual employee shall be fixed as per Finance Department Office Memorandum No.24533/F, dtd.29.09.2022.
6. Interested retired Govt. Servants fulfilling the criteria as envisaged in the above said resolution may apply with his/her full bio-data, one attested passport size photograph,history of services with an undertaking that no vigilance case or Departmental proceeding or criminal prosecution is contemplated or pending against him/her or he/she has not been penalised for misconduct during service by registering post or by hand so as to reach the undersigned by dt.09.06.2023.
7. The contractual engagement may be terminated at any time by the appointing authority,Boudh for unsatisfactory performance, on notice of one month and


in case of any misconduct including, but not limited to, misappropriation, negligence or causing loss to Government without any prior notice.
