WALK-IN-INTERVIEW

The District Administration, Sundargarh intend to hold a Walk-in-Interview on **3rd November, 2023 at 11.00 A.M** in Pragati Mandap, Zilla Parishad, Sundargarh for re-engagement of 12 nos. of Retired Government Engineering Personnel (JEs/AEs) as OSDs on contractual basis for smooth implementation of different developmental works including Mahatma Gandhi NREGS, PMAY-G and other Government flagship programmes. The interested Retired Government Engineering Personnel (JEs/AEs) may attend the interview on the above mentioned date and time. No TA/DA will be provided to the personnel for attending the interview. The re-engagement of Retired Government JEs and AEs shall be pursuant to GA & PG Deptt. Resolution No.23750 dated 27.08.2014 and FD O.M. No.24533/F dated 29.09.2022 and subsequent modifications issued from time to time. The engagement of OSDs is subject to fulfillment of the following eligibility criteria.

Eligibility criteria:

1. The personnel must be a retired employee of Odisha Government from the post of Junior Engineer/Assistant Engineer.
2. The age of the personnel must be within 65 years having good service records and physically fit.
3. The re-engagement as OSDs shall be for one year or till appointment of regular JEs/AEs whichever is earlier.
4. The consolidated monthly remuneration of OSD is Rs.20,000/- per month with additional amount not exceeding Rs.5,000/- per month towards conveyance allowance/mobile allowance etc.
5. One month notice from either side is mandatory to quit/disengage of the OSDs.
