1. Eligibility Criteria:-

Officers who have retired from the Govt. service on attaining the age of superannuation and below the age of sixty five years having good service records and are physically fit shall be eligible for consideration of re-employment.

2. Selection Process:-

i.The Selection process for the post will be done through a Selection Committee in a transparent manner.

ii.Applications are invited from interested persons for engagement of 26 nos of retired Govt. Engineering Personnel as OSD on contractual basis agansit the vacant posts in various blocks of this district.

3. Tenure:-

The engagement shall be for a period of one year or apppintment of regular J.Es / AEs whichever is earlier.

4. Terms & Conditions:-

- i. District shall ensure transparency in selection of OSDs through Open Advertisement by wallk- in-intereview at Z.P Level.
- The re-engagement of retrired Govt. JEs and AEs shall be pursuant to GA & PG Department Resolutiuon No.23750 dated 27.08.2014 and F.D O.M. No.24533/F dated 29.09.2022 and subsequent modifications issued from time to time.
- iii. The re-engagement shall be for one year or appointment of regular JEs / AEs whichever is earlier. While making the engagement the past track record of the incumbent shall be taken into consideration.
- iv. The consolidated monthly remuneration shall be fixed to Rs. 20,000/- per month with additional amount not exceeding Rs.5000/- per month towards conveyance allowance / mobile allowance etc.
- v. The expenditure on payment of consolidated remuneration shall be met out of the Administrative fund available under different Scheme like MGNREGS, PMAY(G)etc. within the permissible limit prescribed under the guidelines.
- vi. The DistrictAdministration shall be responsible for their activities and performances and the payment of monthly remuneration shall be made on obtaining absentee statement from the concerned controlling Authority.

- vii. One month notice from either shall be mandatory to quit / disengage of the OSDs.
- viii. If any district requires more JEs beyond what has been allotted, they may submit a proposal to the Department for approval provided that no. allotted in this letter has been engaged.
